- produce digital images and edit them on a computer, transfer them to a suitable data carrier, master the final production of photos.

The graduate is employed as photographer when taking pictures and during the processing of photos, in work activities in the field of applied photography and in all areas of custom-made photography, in newspapers and magazines, in the newsrooms of media agencies in the promotion and advertising creation, in the exhibition industry, in the publishing houses, in the scientific and research institutes, in the field of scientific and technical photography, in organizations and companies providing specialized or only photographic processing services.

Examples of possible jobs: photographer, photographer in minilab, photojournalist, a portrait photographer and photographer of architecture and landscape.
